Reservation of ownership	Goods shall remain property of the SELLER until BUYER has fulfilled all financial obligations. In the case of attachment, lien or any other claim or action against the BUYER by third parties, SELLER's ownership shall prevail under all circumstances and BUYER warrants the same by acceptance of the ORDER CONFIRMATION and receipt of the goods.
CLAIMS	All claims for incorrect or defective parts must be authorized by the Seller in writing prior to shipping. A photograph of the damaged parts MUST be sent to SELLER before any action will be taken. Return shipping including packing, transport and insurance is the responsibility of the Buyer until the part is received, inspected, and the claim deemed valid. Withholding payment due to a claim is not permitted and the past due amount is subject to interest and all costs associated with collection. Credits for incorrect or defective parts will be issued by the Seller in writing. Electrical, electronic, hydraulic, and all anti-friction parts, once installed, cannot be returned for claim unless installed by Seller's (Schlüsselbauer) personnel. The Seller's decision regarding validity of the claim is final and not negotiable.
RETURNS	All parts returned must be authorized by the Seller in writing prior to shipping. All returned parts must be shipped including packing, transport and insurance at the Buyer's expense. All returns are subject to a 25% restocking fee in addition to any packing, transport, and insurance charges associated with the original delivery. All returns must be in new and un-installed condition in the original packaging free of any dirt or contamination in un-handled form. Electrical and electronic parts may not be returned. All sales of electrical and electronic parts are final. Withholding payment due to a return is not permitted and the past due amount is subject to interest and all costs associated with collection. Credits for returned parts will be issued by the Seller in writing. The Seller's decision regarding validity of return is final and not negotiable.
CANCELLATION / ADJUSTMENTS	All cancellations or adjustments to quantities must be approved by the Seller in the form of a revised Order Confirmation. Seller reserves right to recover all costs from the Buyer associated with cancellation or adjustment in quantities up to and including the full sales price for custom and made to order items. Withholding payment in dispute of validity of costs is not permitted and the past due amount is subject to interest and all costs associated with collection. Pricing and discounts (if any) apply to the originally quoted items and quantities only and Seller reserves the right to adjust pricing and discounts (if any) based on cancellation or quantity adjustment. Terms for cancellation or quantity adjustment apply only prior to shipping or no later than 10 working days after date of order confirmation whichever occurs first. Once goods are shipped terms for returns applies in all cases.
